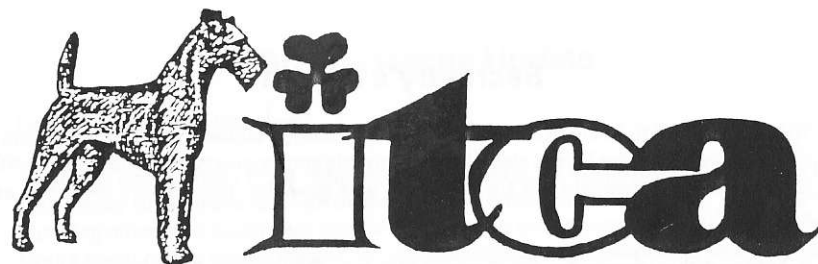

## Breed Rescue Update

Dear Fellow I.T.C.A. Members,

As you all know, I have been responsible for drawing up the proposed Guidelines for Irish Terrier Breed Rescue. A lot of time and effort went into this project. Hours spent studying other pure breed club rescue guidelines to get an idea of how they operated. Hours spent on the telephone and in correspondence with chairpeople and members of rescue committees to determine what these people felt had worked well for their organization and what had not. Hours spent visiting Humane Societies and Animal Shelters within an 100-mile radius of the San Francisco Bay Area to discover how a breed rescue group can most effectively work with these organizations. I do not think this time was wasted as I was able to draw on the expertise and working experience of all these people when writing our guidelines.

You have received correspondence from a concerned member regarding our Irish Terrier Breed Rescue Program which undoubtedly has raised some questions and concerns in you mind, and I would like to address the questions and doubts Mr. Cassity has raised in the hopes that you will realize that your Executive Board is acting only with deep concern for the best interests of our beloved Irish Terriers.

I will start with Mr. Cassity's concern that my appointment as Breed Rescue Coordinator was political. I do not think so. I became an Irish Terrier breeder and exhibitor and member of the I.T.C.A. back in the 60's and like most of you, was only a dues paying member and not an active, working member. I let my membership lapse for a number of years when I was out of active breeding and exhibiting, and re-applied for membership in the 1980's, but a political animal I am not and never have been. I have, however, been very active for a number years as a volunteer with local Humane Societies, particularly the San Francisco S.P.C.A. which is known nationwide for its innovative programs in the field of dog rescue. I think this was probably the main concern for my appointment. The second reason, probably equally valid, I was not at last year's Annual Meeting. Any of you who are active in any kind of organization know what happens if you do not attend a meeting. You get appointed to committees!

Mr. Cassity has expressed concern that our guidelines will be cumbersome and unworkable. I worked very hard to make them as simple as possible, and still cover all contingencies. A national organization cannot function without some kind of guidelines. That organization is accountable to the general membership who has every right to expect them to act for them in a responsible, rational manner, and to do this, we must have some sort of structure.

Another of Mr. Cassity's concerns is that we may be more interested in the dollar bill than in a humane approach to our rescue program. Nowhere in our guidelines is there a minimum or maximum dollar amount set for the rescue of a dog. It does state that each rescue will be handled individually. There is a suggested amount to be charged to the prospective adopters of \$100 or fees incurred in the rescue, whichever is greater. And even this is negotiable, since the right home for a homeless dog is more important than the money received for the placement.

Mr. Cassity's biggest concern is a concern to us too, which is why it is included in the guidelines - Evaluation and Euthanasia. I will quote the paragraph covering evaluation as set forth in the proposed guidelines:

"Keep in mind that not all dogs are adoptable. Dogs with chronic health problems, long-standing skin conditions, severe injuries, or determined bad temperaments, should be euthanized to spare them future suffering. If a dog has a problem or condition which would be expensive to cure, could not be cured completely, and/or which would cause stress to a potential adopter, (i.e., frequent trips to the veterinarian, long term financial strain to the new owner, or constant worry concerning the dog's condition or temperament) then the dog should be euthanized. Always determine the method of euthanasia used by the shelter. If it is not done by humane injection, request permission to take the dog to your own veterinarian. No dog should be euthanized until the situation has been discussed with the Regional Committee and Breed Rescue Chairpersons."

Nearly every dog owner has been faced at some time with the loss of a beloved pet. For me that loss has been a little easier to bear when it has come peacefully from natural causes. The necessity to euthanize has always made it more painful. Proper evaluation of the rescue dog can prevent the adopter of the dog from being faced with this painful decision after they have had time to form an attachment, or prevent a dog from having to live with a possibly painful physical condition because medical treatment is too expensive. Proper evaluation can prevent a phone call from an Animal Shelter saying the dog has been turned in to them, and what do you want to do. Mr. Cassity says that the I.T.C.S.C. has never considered euthanasia in connection with their rescue dogs, but is it possible they passed this painful decision along to someone else? Have all of their rescues been successful? Are all of these dogs healthy and happy in their adoptive homes? I hope so. An unsocialized dog or a dog with a demonstrable bad temperament represents a great risk. We live in a very litigious society and people, understandably, are quite unforgiving if a child is severely bitten. A signed contract is not going to forestall a lawsuit under these circumstances. Will the contract hold up in court? I do not think we want to test it. And how will the owner treat the dog who did this to his child.

Finally, Mr. Cassity has questioned the necessity of having all rescue dogs spayed or neutered before adoption, but in his letter he mentions the growing power of the animal rights groups, particularly here in California where legislation has been passed to attempt to limit the breeding of all dogs. Many responsible dog breeders are already selling their pet puppies under spay/neuter contracts, and many pure breed clubs have established breeder education and responsibility programs which emphasize this practice. Since the papers are not available on many rescue dogs, why should they be bred? We feel that this stipulation is only in the best interests of our breed. If the rescue person comes upon a dog that he feels is a candidate for breeding or the show ring, and the papers are available, then the rescuer takes responsibility for this dog, it is no longer a rescue dog, and this provision is covered in our guidelines.

I hope I have answered any questions you may have had and allayed your fears about the Irish Terrier Breed Rescue Program. We all love our breed or so many of us would not have devoted so many years to it. After all, are not we the caregivers to God's special dogs?

### Courageous, even to death

It happened unexpectedly on Tuesday, January 15. It was at Glade, a small, rural community in the Kootenay region of southern British Columbia, a wild and sparsely populated area.

Ghillie (Baltic Red Sabino) was purchased in Salmon Arm, B.C., from Rolf and Erica Heym of Baltic Kennels, in the fall of 1986 by Rod Retzlaff and family. They knew they preferred terriers. They did their homework at the library and decided on the Irish Terrier. The books all said, "excellent family dogs and very courageous." That he would be an excellent family dog was immediately apparent. Ghillie loved the three boys and accompanied them everywhere. But what about courage?

Mortal danger happens suddenly. There's seldom any warning. It was about 3:15 p.m. Ghillie and Aaron, age 10, were nearly home. The sidewalk was narrow with high snow banks on either side. They rounded the last corner and came face to face with a full-grown female cougar. The cougar, hungry and on the prowl, could hear them coming. She was ready, but not for the likes of Ghillie. One look and Ghillie instinctively knew the danger and his responsibility. Without hesitation, he attacked. The fact that the cougar was many times larger than he and that he was surely about to die did not deter him. Ghillie attacked with such swiftness and ferocity that it caught the cougar off guard. Cats are fast. They grab their prey by the neck and kill instantly but there was no time for that. Ghillie came head on, straight into the cat. The cougar, suddenly on the defensive, with more than she had bargained for, lost her opportunity for an easy victim.

Mission accomplished. Aaron made it to the house. He was safe. But Aaron was not about to abandon his friend. He bravely rushed back, armed with ski poles and snowballs to the one-sided battle. It was not enough, so he rushed next door for help. Debbie Girard quickly came to the rescue, banging a snow scoop on the patio to make loud noises and finally, in desperation, flinging the scoop at the cat. The cougar had Ghillie by the head and was tearing at it but she was now threatened on all sides. She decided on retreat, dropped the dog and took refuge in the open garage. Debbie ran to the phone.

After a few minutes, Ghillie staggered to his feet, gravely injured. His eye was hanging down his cheek, his skull was torn open and the brain exposed but he knew danger was still nearby. In spite of his injuries, he gamely entered the garage, ready to do battle again. Mercifully, the authorities arrived and destroyed the cougar.

Moments later, Mrs. Retzlaff arrived. There was Ghillie, by now in shock, his eye hanging down and bleeding, but wagging his tail in welcome. On examining the extent of his injuries, the eye, the exposed brain and battered skull, the vet was highly skeptical but Ghillie was so gritty, no quitter. Two days later, he was eating and wagging his tail. Two weeks later, he was running around, albeit blind in one eye, but happy and playful as if nothing had happened. Courage had saved the day. The Irish Terrier Association of Canada is very proud of Ghillie. We're also very thankful and grateful for the quick actions and bravery of Aaron and good neighbour Debbie Girard.

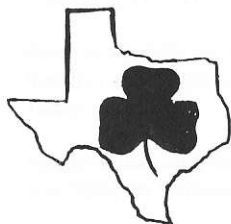

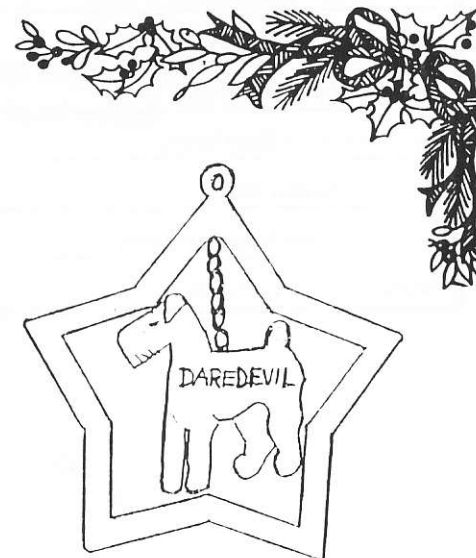

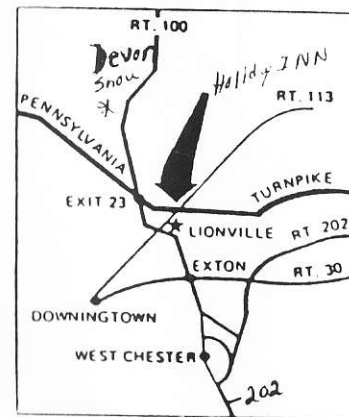

## Montgomery Weekend Update
