Other Irish Terrier exhibitors included Watson and Kay Hoos, of Wahoo kennels; Ed (Pop) Sayres, father of Dr. Joe Sayres; and Alfred Niese and Frances Thord-Gray, both active in the ITCA in days past.

MONTGOMERY WEEKEND

Driving north from the central Illinois cornfields in the warm dusk of an early October evening, my mind wandered back and forth between thoughts of radar traps and whether I had included a wide enough variety of apparel for the coming weekend. I had the rubber boots, the down vest and down-filled coat, the rubberized raincoat, and two spare plastic fold-up raincoats for emergency use if needed, plus the usual sweaters and wool socks. I was just clearing the first toll-plaza on I-294 around Chicago when panic struck. I had forgotten to pack any gloves or mittens. Well--at that point I decided I could just keep my hands in my pockets if needed. The next morning, leaving O'Hare in a nasty mizzle, I again reflected on the oft-repeated phrase that "weather travels from west to east. . ." Philadelphia, deceptively, was warm and sunny, totally pleasant and full of Indian summer.

Any thought of such balmy conditions persisting (I understand Montgomery had shirt-sleeve weather on some occasions still within the memory of some of our long-time exhibitors) was dispelled on the ride back to Valley Forge from the rather cool Hatboro show when the skies opened and the ensuing deluge almost obscured the Turnpike. Next day, at the Devon show the sun was in evidence but the temperature had pretty well plummeted, and I thought of how wise Jim Reed had been in his solicitation letter as chairperson of the trophy committee when he had said I had promised the usual Montgomery weather (which I hadn't) and he advised all to come prepared.

Pre-show festivities began Saturday evening in the hospitality room at the Holiday Inn in Valley Forge. To June Kennedy must go the credit for arranging this well stocked gathering place for us, and the crowd assembled there would seem to indicate appreciation of this facility. The annual meeting was convened at 5:30 p.m. for roll call and appointment of tellers, and then recessed while the ballots were counted. While the tellers were doing their job, the rest of us enjoyed dinner, and shortly thereafter the election results were announced, a raffle was conducted, and awards were presented. After the dinner and annual meeting were concluded, the hospitality room was again opened.

Montgomery show morning dawned damply and coldly though as the morning wore on the sun did overcome the clouds (but not the cold) and the mud underfoot, while present, was not a real shoe-eating hazard. Those of us privileged to be present saw one of the most spectacular entries of Irish in many years. Of the 53 entries listed in the catalog, only 6 were absent, and only one of the 16 entries in the sweepstakes was not in the ring.

Our trophy table was really beautiful, and Jim and Laurie Reed, with Jeanene MacDonald, deserve many thanks for manning it. After opening our show with a bagpipe selection, Gregor Hetzel laid the pipes aside and acted as Chief Ring Steward, aided by Ginger Johnson, and thanks to both of them we had a very well run ring with sweepstakes judge John Best finishing up exactly on time for Dennis Barnes to take over the judging of the official and non-regular classes. It certainly was a thrill to see so many Irish of such quality and in such fine condition. When the best of breed class entered the ring, the sun was shining and the twenty-odd Irish really sparkled against the marvelous green of the turf. It is a sight long to be remembered by all of us present--so many great and beautiful dogs all together at once.

Also deserving of mention is the response to the advertising request sent out by Frank Kennedy--we had a return of 19½ pages--surely one of the best returns we have ever had.

There was one trophy which was received too late to be included in the catalog premium list and was, therefore, presented outside the ring after the judging. This was a very lovely silver-plated Revere bowl, given for the first in the Veteran Dog Class, by LTC and Mrs. Werner G. Schmidt in memory of Marie Sch. Schmidt. This trophy was won by Ch. Blazer's Fusilier, owned by Mary Gately. For me, as they always do, the Veterans' Classes presented a thrill which brings me close to tears--no one has convinced those Irish that they are Veterans, and they really do hold their heads high and strut and challenge.

As I sat in the Philadelphia airport waiting for my (late) flight back to Chicago looking out at the gray sky and intermittent showers, I thought again how fortunate we had been that morning. The sun had shown on our marvelous red dogs and they had sparkled against the green turf as they showed and sparred and challenged and presented us with the spectacular

MINUTES OF THE ANNUAL MEETING

IRISH TERRIER CLUB OF AMERICA

October 6, 1979
King of Prussia, Pennsylvania

The Annual Meeting of the membership of the Irish Terrier Club of America took place both before and after the dinner at the Holiday Inn, King of Prussia, PA, Saturday, October 6 1979. The meeting was called to order by President George Kidd shortly after 6:00 p.m. Following a brief statement of welcome by the President, the Secretary, Nancy Hetzel, read the roll call. Exactly fifty ITCA members answered "present," a quorum. Twelve additional members were latecomers. The dinner was also attended by a number of non-member spouses and guests.

The tellers selected by those members present for opening and counting of the ballots for the votes for Club officers and Board of Governors were Helen Best, Jim Kelly, and Mary Roberts. This committee retired to the "upper room" and later emerged with the following results:

Retiring AKC Delegate was Michael Gately, retiring Treasurer Jim Wilson, and retiring Board members were James P. Kelley Jr., June G. Kennedy, and Robert C. Peters. Those remaining on the Board are: John S. Best, Phyllis J. Kendrick, Charles F. Ritter and Ellis F. West (Class of 1980); Dennis M. Barnes, Jeanene M. MacDonald, Joseph P. Sayres, and Mary Welch (Class of 1981).

The tellers had counted 140 ballots returned by the membership. Parts of several were disqualified because instructions had not been followed or intentions of voter were unclear.

The Secretary reported that the ITCA has a current membership totaling 218 including four new members approved by the Board that afternoon, all four present: Mr. and Mrs. Charles McCabe (June), Mr. George Murphy and Miss Erin Murphy, a junior member. Forty-two past members were dropped from the 1979 roster for non-payment of dues; two members

resigned after dues had been paid. There are thirty-seven new ITCA members since the last annual meeting, and one former member has reapplied for membership after membership had lapsed.

The report of the Treasurer was read by Jim Wilson and appears elsewhere in this Newsletter. Jim said that although costs are continually going up, the treasury has held a stable figure during the last year because of the number of new members, a good sale of Breed Books, etc.

John Best reported that the Gary Hammer Pedigree Book project was set for publication and that the Board had decided to solicit subscriptions from the membership at \$12.50 to a total of \$500, half the cost of publication, before beginning the job. More than the \$500 in subscriptions was raised from the membership on the spot!

Gary Johnson reported that there had been five Newsletters during the past twelve months. He asked if anyone had solved the riddle in the last Newsletter, and Cory Klemperer correctly identified Mr. Ryan as the handler of the Irish Terrier.

Mary Roberts, the new puppy referral coordinator, announced that she had completed all the work answering letters, etc., which she had inherited from Pat Casey. She requested that Club members send her the information on new litters promptly.

Details of Joe Sayres' Symposium Committee report appear in the minutes of the Board meeting.

Report of the Judges Selection Committee, Marion Honey, Chairman, appear in the Newsletter. As a result of the membership preference, the Board has invited judges as follows, pending AKC approval: Joe Sayres, Montgomery, 1980; Tom Gately, the Traveling Specialty at Chain-O-Lakes, IL, June, 1980. (Mrs. Riggs is the judge for February, 1980.) If finances will permit, Nick Calicura may judge Montgomery, 1981.

Margaret Stone, Chairman of the Nominating Committee, mentioned that the Committee had nominated in the spirit of the constitution, new people, with geographical balance of the Board in mind.

Brief reports of the year's activities and progress were presented for the regional Clubs: John Best for Chicago, Mary Gately for New York, Ellis West for Northern California, Jim Reed for Southern California, Jim Kelly for Greater Detroit, Carol Butterworth for New Jersey.

John Best announced that Linda Honey was the first recipient of a new award agreed upon by the Board last year: \$100 for a Breeder who handled his or her own dog to Best of Breed at a parent Club Specialty. Linda had achieved this at the Traveling Specialty at Battle Creek last May.

Linda Honey read the names of Club members whose dogs had won championships during the year, and medallions were presented.

John Best announced that he had one copy of the 1928 ITCA Breed Book and two of the 1948. These were successfully auctioned off to the highest bidders by Bob Peters (erstwhile) southern tobacco auctioneer.

The meeting was adjourned by President George Kidd at 9:30 p.m.

Minutes of the Meeting

BOARD OF GOVERNORS, IRISH TERRIER CLUB OF AMERICA

The Board of Governors' meeting on Saturday, October 6, 1979, was held in two shifts, to accommodate the long agenda and to insure that the following day of the show could be enjoyed by all. Board members present when the first meeting was called to order by President George Kidd at 2:30 p.m. were: Best, Honey, Kendrick, Kennedy, Kidd, MacDonald, Ritter, Sayres, West, Joyce Wilson, Jim Wilson and Secretary Hetzel. Invited guests in attendance were Mike Gately, Sue Griffiths, Cory Klemperer and Liz Wilson. Peters arrived late.

Reading of the minutes of the October, 1978, Board meeting were dispensed with as they had appeared in the Newsletter. Board action by mail during the year had also been reported in the Newsletter.

There was no report from the President or Vice President. The Secretary mentioned the current membership figures (details appear in minutes of Annual Meeting of general membership). The Treasurer's report was presented by Jim Wilson and approved. It appears in the Newsletter.

I. Cost of Specialty Shows

Early in 1979 John Best had made a detailed study of the costs of our three annual Specialty shows and the Club's finances, which had been sent to all Board members. In reviewing this, John Best said that the Club had lost money on every specialty since 1975 with the exception of Montgomery, 1978, which added \$67 to the treasury. Facts he mentioned were that a hospitality room costs about \$150, including the refreshments; we realize nothing from advertising at the Traveling Specialties because the profit goes to the all-breed club running the show; we pay \$300 to the Associated Terrier Clubs for the February show for which we receive the premium list, catalog pages, superintendent, prize money, building rent, etc. John said the item that throws things off is the fees for judges which vary considerably; some judges are free. He mentioned that three ways we might face the problem were to budget judges' expenses, spread out and stabilize trophy costs, and sell more advertising. John felt strongly that we should continue to hold the Specialty in New York in February because of the prestige of Westminster, other terrier clubs hold specialties then, some have their annual meetings then, and ITCA should be a part of the weekend. He felt that with proper scheduling of judges and work, the Club could continue to hold three specialties per year. Ellis West brought out the point that the February show has declined in entries in recent years, he felt, because of expense, weather, etc. Charles Ritter said that the February show is the one where we lose the most. He moved and it was seconded and carried that we continue to keep track of costs in 1980 and 1981 with detailed analysis of all the national specialties. John Best said he would be happy to work with the Treasurer on this. Ritter so moved; it was seconded and carried.

II. Illegal Practices

Next item was the proposed statement of Board and Club policy requested in a letter from Isabelle O'Connor re "ear crimping" and other illegal practices. Joyce Wilson felt the Club has been lax in educating members and that breeders should instruct buyers against these practices. Jeanene MacDonald said that if our purpose is to better the Irish Terrier, it should be done with breeding. June Kennedy mentioned that we are not responsible for actions of judges who know the AKC rules and we should instruct handlers. Ellis West said he had worked with handlers in the past and knew that many illegal practices could be used. He said that we should advise Club members of the rules and members' moral responsibility via the Newsletter and not presume to tell the judges and AKC what to do. Joe Sayres

agreed that we should emphasize educating breeders and ITCA members. It was agreed that Ellis will draft a new statement of policy as a result of this discussion, and it will be sent to the Board for approval and then to the members.

III. Gary Hammer Pedigree Book Project

John Best said the book is all typed, ready to be reduced to 8½ x 11 format, can be run off at his office, collated, some kind of binding provided for 200 copies, for about \$1,000. It is a compilation of four-generation (where available) pedigrees of the Irish Terrier champions of record from the AKC archives. It could be supplemented periodically. John proposed that because our treasury is low, 50% of the cost should be underwritten by pre-publication orders at \$12.50 each. Ellis West suggested that the ITCA solicit subscriptions for the project's publication at \$12.50 and that if \$500 was received in the next sixty days, work would begin. This was moved, seconded and carried. It was also agreed after some discussion that different bindings be available at optional prices, including the format of three-hole punched sheets for use in a loose-leaf binder.

IV. Symposium Committee

Joe Sayres reported on his committee for the ITCA Statement at the proposed Terrier Symposium. He said that because of the illness of Dr. T. Allen Kirk Jr., the major proponent of such a symposium, there would not be one soon. However, he will continue gathering ideas and remarks on the breed from ITCA members and judges as a useful project. Joe passed out a presentation of the ITCA standard and a fun quiz that he had used at a meeting of judges recently in California, designed to point up the differences in Irish from other terriers. He is looking for a good sketch or Irish Terrier model which will illustrate these points. He feels that getting information to judges to educate them on the Irish Terrier, with the use of visual aids such as motion pictures, etc., should be an on-going project.

About here the first installment of the Board meeting was adjourned at 5:00 p.m. The second was called to order at 10:10 p.m. following the general meeting, by President George Kidd. Board members in attendance were: Best, Diamond, Mary Gately, Griffiths, Hetzel, Honey, Kendrick, Kidd, MacDonald, Ritter, Sayres, West, Joyce Wilson, and Liz Wilson.

V. Guidelines for Selecting Specialty Show and Sweepstakes Judges

The Board took up the matter of proposed guidelines for selecting specialty show and sweepstakes judges. Several months ago, a draft was submitted to the Board by Bob Peters. Alternate suggestions were proposed by the Board after due consideration. The whole was consolidated and presented by Jeanene MacDonald. After full discussion of each point, the Board moved, seconded and approved the Guidelines one by one. These Guidelines appear at the end of the Board minutes.

VI. Trophy Committee

The report and recommendations of a special Trophy Committee of Charles Ritter, Chairman, John Best and Marion Honey was discussed and approved. Ellis West suggested that the ITCA should have uniform rosette awards for Winners and above at our three specialties (Winners

Dog, Winners Bitch, Best of Opposite Sex and Best of Breed) and that the Specialty Show Chairman be specifically requested to arrange for these at the Traveling Specialties. This was approved.

VII. Puppy Pamphlet

Ellis West distributed a second draft, somewhat condensed, of his work on a new pamphlet for new puppy buyers or prospective buyers. He asked the Board to review it and return it to him with comments in one month.

VIII. ITCA Ad in Dog World

A change in the ITCA ad in Dog World magazine was discussed. Ellis West agreed to design a new ad with an appropriate logo that would be eye-catching rather than wordy for Board approval. The ad should include Mary Roberts' name as puppy referral coordinator.

IX. Membership Applications

Following some discussion of the Board's previous rejection of her membership application, it was agreed that the Secretary ask Kathleen Ford to reapply if she still wishes to be a member and has a sponsor.

X. Eaglen's Gift to Club

It was approved that we apply the gifts of Nell and Ed Eaglen to the Club which had a value of over \$250 toward their future membership dues as had been done for their 1979 dues.

XI. New Business

Jeanene MacDonald proposed that Ellis West be appointed Chairman of a committee, the composition of the committee to be determined later, and that he begin some of the preliminary work toward the publication of the next ITCA Breed Book. Ellis agreed, and he will also prepare a list of names for the Committee to be approved by the Board.

XII. 1981 Traveling Specialty

Regarding the location of the 1981 Traveling Specialty, Liz Wilson suggested that Ellis West explore the possibility of the Irish Terrier Club of Northern California acting as host. Ellis agreed to do this, and it was so moved, seconded and passed.

XIII. ITCA Support of Junior Showmanship

Regarding this issue, the Board agreed after some discussion that this is the function of a local or regional or an all-breed club rather than the ITCA.

XIV. Regarding Bob Peters' suggestion for gathering information on Irish Terrier litters vs. the heartworm preventative drug, Caricide, the Board appointed Bob Peters to do this.

XV. It was moved and seconded and approved that ITCA budget maximum expense for the AKC Delegate at \$25 per meeting (\$100 per year) plus telephone and mailing expense.

XVI. The secretary is awaiting volunteers to take over the job of Editor of the Newsletter from Marie and Gary Johnson who have done the job so splendidly but would now like to relinquish it. This appointment is held in abeyance.

XVIII. 1980 Nominating Committee

The 1980 Nominating Committee was selected as follows:

James S. Kelly, Chairman; Diana Martin; Susan Young.

Alternates: Edna M. Sullivan and Margaret Conneely.

XIX. 1980 Judicial Selection Committee

Joseph P. Sayres was appointed chairman of the 1980 judicial selection committee and Linda Honey and R. James Wilson will serve with him.

XX. Charles F. Ritter agreed to remain as Show Coordinator for another year.

XXI. Judge, 1981 New York Specialty

The Secretary will advise the Board of the next three names on the list (after Sayres, Tom Gately and Calicura) as selected by the membership this year and send these three names to the Board for vote.

XXII. The possibility of a Board meeting at the Traveling Specialty hosted by the Chicago Club in June, 1980, was discussed.

The Board of Governors, by acclamation, gave a warm and enthusiastic vote of thanks and appreciation to Michael Gately, our retiring AKC Delegate, for his many years of splendid and faithful service in behalf of Irish Terriers and to the ITCA.

As the hour got later and later and finally earlier and less early, the Board of Governors talked and worked faster and faster. The meeting was adjourned Sunday, October 7, 1979 at 2:00 a.m.

GUIDELINES FOR SELECTING SPECIALTY SHOW JUDGES

1. A Judicial Selection Committee of three persons shall be appointed by the Board of Governors at its annual meeting in October until this time is changed by further Board action.
2. The Committee shall submit to the entire membership by May 1 of each year following their appointment the list of all judges licensed by the AKC to judge Irish Terriers, with indication of those judges who have judged ITCA Specialty Shows in the two previous calendar years or who are already scheduled to judge one as not to be voted for.
3. The membership shall return their marked lists to the Chairman of the Judicial Selection Committee within 30 days after mailing. Each member may vote for up to three judges, each vote to carry equal weight.
4. The Chairman shall tabulate the ballots (votes) and mail the marked lists to each member of the committee to confirm the count. When the count is confirmed, the Chairman shall inform the Secretary of the results.

The top six choices will constitute a "pool." The Judicial Selection Committee will select judges from the pool for the Specialty Shows of the following year, with the exception of the Traveling Specialty. There must be some freedom in choosing a judge for the Traveling Specialty, as the all-breed club sponsoring the show may already have on its panel a suitable judge acceptable to the ITCA. Any judge in the "pool" who has not officiated within a two-year period will be dropped from the "pool," but may be renominated by the membership.

5. Names of the top six judges selected by the membership vote and comprising the "pool" will be published in the Newsletter, listed alphabetically.
6. Thereafter, annually, a vote will be conducted by the then current Judicial Selection Committee to select additional judges for the "pool" to replace those who have been assigned to judge a Specialty.
7. The Judicial Selection Committee shall be authorized to expend for the Specialty shows for which it is functioning, but to operate within a certain amount to have been determined by the Board of Governors (at a previous meeting). In the event a judge does not charge for his/her services, the trophy committee shall be instructed to purchase a suitable gift for the judge as a token of gratitude.

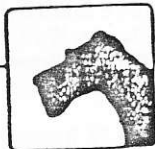
